CITY ORDINANCE NO. 261

August 17, 2000

**AN ORDINANCE CREATING A SPECIAL ACCOUNT TO BE KNOWN AS "MASSKARA FESTIVAL 2000" FOR THE CELEBRATION OF MASSKARA FESTIVAL AND PROVIDING FOR THE MANNER IN THE UTILIZATION THEREOF.**

Be it ordained by the Sangguniang Panlungsod of Bakoled that:

**SECTION 1-** There is hereby created and established a Special Account to be known as "MASSKARA FESTIVAL 2000" for purposes of the celebration of the Masskara Festival for the Year 2000;

**SECTION 2 -** All funds generated by way of grants, contributions, solicitations, financial assistance, and the like, coming from all sources shall be deposited to the said Special Account and which fund shall be utilized for all expenses in connection with the celebration of Masskara Festival 2000;

**SECTION 3 -** Withdrawals from the Special Account as may be needed in the course of and in connection with the festival/affairs/activities of Masskara Festival 2000 shall bear the joint signatures of the Masskara Festival 2000 Director and the Honorable City Mayor or his duly authorized representatives;

**SECTION 4-** A financial report shall be submitted by the Masskara Festival Director within a period of thirty (30) days from the culmination of Masskara Festival 2000;

**SECTION 5 -** That excess funds shall go back to the General Fund subject to the appropriation by the Sangguniang Panlungsod;

**SECTION 6 -** That this Special Account shall follow the auditing rules and procedures as provided for under the Local Government Code;

**SECTION 7-** This ordinance shall take effect immediately upon its approval.




