CITY ORDINANCE NO. 268
October 27, 2000

AN ORDINANCE APPROVING THE TEMPORARY CLOSURE OF THE ROAD FROM THE JUNCTION OF SAN JUAN-LUZURIAGA-ARANETA STREETS IN ORDER TO PREVENT ALL VEHICLES FROM ENTERING THE PREMISES OF THE CITY HALL FOR THE PROTECTION OF OUR POWER LINES UNTIL THE CONTROVERSY BETWEEN THE CITY AND THE CENTRAL NEGROS ELECTRIC COOPERATIVE (CENECO) SHALL BE RESOLVED AND TO PREVENT ANY UNTOWARD INCIDENT THAT WOULD JEOPARDIZE THE SAFETY NOT ONLY OF THE CITY HALL BUT ALSO OF THE PUBLIC, PER LETTER-REQUEST OF THE HONORABLE CITY MAYOR, OSCAR R. VERDEFLOL DATED OCTOBER 27, 2000, DOCKETED AS SP CORRESPONDENCE NO. Y2-1209.

Be it ordained by the Sangguniang Panlungsod of the City of Bacolod, that:

Section 1. - The temporary closure of the road from the junction of San Juan-Luzuriaga-Araneta Streets is hereby approved in order to prevent all vehicles from entering the premises of the City Hall for the protection of our power lines until the controversy between the City and the Central Negros Electric Cooperative (CENECO) shall be resolved and to prevent any untoward incident that would jeopardize the safety not only of the City Hall but also of the public, per letter-request of the Honorable City Mayor, Oscar R. Verdeflor dated October 27, 2000, docketed as SP Correspondence No. Y2-1209.

Section 2 - This ordinance shall take effect upon its approval.
