**CITY ORDINANCE NO. 539**

June 1, 2011

**AN ORDINANCE DECLARING THE EXISTING CANTEEN AT THE NGC AND ALL THOSE CANTEENS TO BE OPERATED BY THE CITY GOVERNMENT AS SOCIO ECONOMIC ENTERPRISE UNITS.**

**WHEREAS**, the existing canteen at the NGC compound, and those soon to be operated by the City Government of Bacolod was not declared as Socio-Economic Enterprise Unit;

**WHEREAS**, declaring the same will increase the revenue of the City of Bacolod;

**WHEREAS**, one of the consequences is that canteens to be operated by the City will not be maintained and supervised well because they were not considered as Socio-Economic Enterprise Unit.

**NOW THEREFORE, BE IT ORDAINED** by the Sangguniang Panlungsod of Bacolod City, that:

**Section 1. - DECLARATION OF POLICY.** This ordinance shall declare the existing canteen at the NGC and all canteens soon to be operated by the City of Bacolod as Socio Economic Enterprise Units. The City shall uphold the purpose of the canteens as revenue generating units.

**Section 2. - THE CANTEEN COMMITTEE.** There shall be created a Canteen Committee that will supervise the canteens operated by the City of Bacolod.

**Section 3. - COMPOSITION OF THE CANTEEN COMMITTEE.** The Committee shall have the following functions, to wit:

**Section 4. - FUNCTIONS OF THE CANTEEN COMMITTEE.** The Committee shall have the following functions, to wit:

- a. To supervise/administer the canteens operated by the City of Bacolod
- b. To identify the amount of rentals of the spaces occupied
- c. To see to it the proper maintenance and cleanliness of the canteens
- d. To ensure tat the lessee is paying their rental promptly
- e. To identify possible lessees of the spaces in the canteen and recommend the same to the city Mayor for his approval
- f. To inspect if all occupants of the canteen have accomplished their Mayor's Permit and Sanitary Permit to operate
- g. To determine the reasonable rental fee of all concessionaires

**Section 5. MONTHLY REPORT** The Canteen committee shall prepare and submit a Monthly Report to the City Mayor and to the Sangguniang Panlungsod.

**Section 6. SEPARABILITY CLAUSE** If any provision of this ordinance is held invalid, the other provisions not affected shall remain in full force and effect.

**Section 7. REPEALING CLAUSE** All ordinances or rules inconsistent with this ordinance are hereby repealed or modified accordingly

**Section 8.** - This ordinance shall take effect fifteen (15) days after its publication in at least two (2) newspapers of local circulation.



Comments : Passed.  
Councilors Al Victor A. Espino and Carlos Jose V. Lopez were out of the Session Hall when this ordinance was passed.

Councilor Archie S. Baribar objected for the passage of this ordinance for the following points he stated as follows:

1. The body did not resolve whether the contract with the Gonzaga Family affecting the construction of the Government Center would allow the establishment of the city operated canteen within the premises.
2. While the ordinance enumerated the powers of the canteen committee, it does not include the rule making power of the committee. In short, the authority or power of the canteen committee is only limited as enumerated from A to G of the proposed ordinance. It is not authorized to set certain rules.
3. On the matter of the rescission of contract, should there be a need that a particular contract of a particular concessionaire has to be rescinded, the ordinance does not have any provision on any process in order to affect rescission of the contract.
4. The above points should be addressed first for the city ordinance to be more effective.






