CITY ORDINANCE NO. 281

March 8, 2001

AN ORDINANCE ESTABLISHING/DESIGNATING THE LIGA NG MGA BARANGAY HALL LOCATED AT 2ND FLOOR, ALONG SAN JUAN STREET, CITY OF BACOLOD, AS THE OFFICIAL CENTER OF ALL THE ACTIVITIES OF THE LIGA NG MGA BARANGAY MEMBERS.

WHEREAS, the Liga ng mga Barangay-Bacolod Chapter, a government entity composed of all the 61 Punong Barangays and their councils, should have a place wherein to convene and assemble for whatever activity it may have at any day of the year;

WHEREAS, the Liga ng mga Barangay Hall, as early as its inauguration in October 2000, has consistently provided a home for all the Barangay Captains of the City of Bacolod;

WHEREAS, the Liga ng mga Barangay Hall is one of the few edifice all over the Philippines constructed for the honor and benefits of the Liga ng mga Barangay Members;

WHEREAS, from the time of its Inauguration onwards, it has never ceased to be the center of social and official functions exercised by the Liga Members;

WHEREAS, it is but fitting and proper that the present Liga ng mga Barangay Hall be recognized as the official hall of the Liga Members.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section 1 - This ordinance shall be known as "An ordinance establishing/designating the Liga ng mga Barangay Hall located at 2nd Floor, along San Juan Street, City of Bacolod, as the Official Center of all the activities of the Liga ng mga Barangay Members.

Section 2 - The Liga ng mga Barangay Hall, located at 2nd Floor, along San Juan Street, City of Bacolod, is hereby established and designated as the official center of all activities of the Liga ng mga Barangay Members.

Section 3 - This ordinance shall take effect immediately upon its approval.
