**CITY ORDINANCE NO. 285**  
**September 6, 2001**

**AN ORDINANCE AMENDING CITY ORDINANCE NO. 261, SERIES OF 2000.**

Be it ordained by the Sangguniang Panlungsod of the City of Bacolod in regular session assembled that:

**Section 1.-** City Ordinance No. 261, Series of 2000 is hereby amended, to read as follows, to wit:

**AN ORDINANCE CREATING A SPECIAL ACCOUNT TO BE KNOWN AS "MASSKARA FESTIVAL 2001" FOR THE CELEBRATION OF THE MASSKARA FESTIVAL AND PROVIDING FOR THE MANNER IN THE UTILIZATION THEREOF.**

**Section 2. -** There is hereby created and established a Special account to be known as "MassKara Festival 2001" for purposes of the celebration of the MassKara Festival for the year 2001;

**Section 3. -** The excess fund of P742,231.48 generated after deducting all expenses of MassKara Festival 2000 shall form part of the Special Account of MassKara Festival 2001;

**Section 4. -** All funds generated by way of grants, contributions, solicitations, financial assistance, and the like, coming from all sources shall be deposited to the said Special Account and which fund shall be utilized for all expenses in connection with the celebration of MassKara Festival 2001;

**Section 5. -** Withdrawals from the Special Account as may be needed in the course of and in connection with the festival/ affairs/activities of MassKara Festival 2001 shall bear the joint signatures of the City Mayor, Over-all Chairperson of the MassKara Festival 2001 and the City Treasurer or their duly authorized representatives;

**Section 6. -** A financial report shall be submitted by the MassKara Festival Chairperson within a period of thirty (30) days from the culmination of MassKara Festival 2001;

**Section 7. -** That excess funds shall go back to the General Fund subject to the appropriation by the Sangguniang Panlungsod.

**Section 8. -** That this Special Account shall follow the auditing rules and procedures as provided for under the Local Government Code.

**Section 9. -** This ordinance shall take effect immediately upon its approval.






