



CITY ORDINANCE NO. 287

October 4, 2001

AN ORDINANCE APPROVING THE ADOPTION AND RATIFICATION OF THE RULES AND REGULATIONS GOVERNING REPUBLIC ACT NO. 9048, PARTICULARLY RULE 18 OF ADMINISTRATIVE ORDER NO. 1, SERIES OF 2001, ISSUED BY THE OFFICE OF THE CIVIL REGISTRAR GENERAL, AUTHORIZING THE CITY TREASURER OF THE CITY OF BACOLOD TO RECEIVE PAYMENTS THEREOF.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

WHEREAS, Republic Act No. 9048 amended Articles 376 and 412 of the Mandatory Law provides, "No entry in a civil register shall be changed or collected without judicial order, except for clerical or typographical errors and change of first name or nickname which can be corrected or changed by the concerned City or Municipal Civil registrar (C/MCR) or Consul General in accordance with the provisions of this Act and its implementing rules and regulations";

WHEREAS, it is mandatory that Administrative Order No. 1, series of 2001 issued by the Office of the Civil Registrar General which implements the Rules and Regulations governing Republic Act No. 9048, be ratified by the Sangguniang Panlungsod;

WHEREAS, Rule 18 of same Administrative Order No. 1, series of 2001 provides, authority to collect filing and other fees - The City Civil Registrar is hereby authorized to collect from every petitioner a filing fee in the amounts hereunder enumerated:

- a. P3,000.00 - Filing fee for change of first name or nickname
- b. P1,000.00 - Filing fee for the correction of clerical or typographical error
- c. P1,000.00 - Service fee for change of name or migrant petitioner
- d. P 500.00 - Service fee for correction of clerical or typographical error for Migrant petitioner.

WHEREAS, for the purpose of centralization pursuant to the collection of filing and other fees, it is proper to authorize the City Treasurer of Bacolod to receive the same.

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, to approve the adoption and ratification of the rules and regulations governing Republic Act No. 9048, particularly Rule 18 of Administrative Order No. 1, series of 2001, issued by the Office of the Civil Registrar General, authorizing the City Treasurer of the City of Bacolod to receive payments thereof.
