



**CITY ORDINANCE NO. 291**  
**December 6, 2001**

**AN ORDINANCE ESTABLISHING TEMPORARY FLEA MARKETS AT THE RECLAMATION AREA FROM DECEMBER 10, 2001 TO JANUARY 10, 2002.**

**WHEREAS**, traditionally as in previous SP Resolutions (Res. Nos. 480, series of 1991; 742, series of 1993; 1024, series of 1994; and 1011, series of 1998), the City has allowed vending in certain areas of the city during the Christmas season;

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

**Section 1** - This ordinance shall be known as "An Ordinance establishing temporary Flea Markets at the Reclamation Area from December 10, 2001 to January 10, 2002."

**Section 2** - The Flea Market shall be established in the following areas, which shall be closed to traffic from December 10, 2001 to January 10, 2001:

- a. One fourth (1/4) of the road beginning at the corner of San Juan St. and Rizal Extension, going down to the reclamation area.
- b. One fourth (1/4) of the reclamation area road passing in front of the Jeepney Terminal, west side of the road fronting the Vendors' Plaza and Manokan Country, going toward the BAY Center.

**Section 3** - Implementation.

- a. The Chief Executive shall designate the specific areas where items of similar nature may be sold.
- b. Likewise, the Chief Executive shall formulate guidelines for the effective implementation of this ordinance, and shall ensure that appropriate fees that may be due to the City are collected.
- c. The sale of fish, meat and vegetables is strictly prohibited in all flea markets areas.
- d. Firecrackers shall be sold only in the area designated for the sale of these items.

**Section 4** - Effectivity - This ordinance shall take effect immediately upon approval.




