CITY ORDINANCE NO. 294  
JANUARY 17, 2002

**AN ORDINANCE NAMING 13TH STREET FROM GATUSLAO STREET TO M. HILADO STREET TO BISHOP CASIMIRO LLADOC STREET.**

**WHEREAS**, Bishop Casimiro M. Lladoc was the first bishop of the Diocese of Bacolod from year 1933 to 1951,

**WHEREAS**, during his tenure as Bishop of the Diocese of Bacolod, he was primarily instrumental in constructing several Catholic institutions like La Consolacion College, Sacred Heart Seminary, Sacred Heart Shrine in Lupit, Carmelite Monastery, among others;

**WHEREAS**, the naming of 13th Street as Bishop Casimiro M. Lladoc Street is but fitting considering that Bishop Casimiro M. Lladoc was responsible for bringing in the La Salle Brothers to Bacolod, and consequently the establishment of the now University of St. La Salle;

**WHEREAS**, Bishop Casimiro M. Lladoc was also responsible for the coming to Bacolod of the Redemptorist Fathers who eventually constructed and gave meaning to the Redemptorist Church at B. S. Aquino Drive, Bacolod City;

**NOW, THEREFORE**, be it ordained by the Sangguniang Panlungsod, that:

**SECTION 1-** 13th Street from Gatuslao Street to M. Hilado Street shall be named "Bishop Casimiro M. Lladoc Street" in honor of Bishop Casimiro M. Lladoc.

**SECTION 2 -** This Ordinance shall take effect upon approval.




