CITY ORDINANCE NO. 302
MAY 23, 2002

AN ORDINANCE CHANGING THE NAME OF THE MANSILINGAN RELOCATION AND REHABILITATION PROJECT ELEMENTARY SCHOOL TO HANDUMANAN ELEMENTARY SCHOOL.

WHEREAS, the Mansilingan Relocation and Rehabilitation Project Elementary School has existed as an Educational Institution since 1975;

WHEREAS, the Mansilingan Relocation and Rehabilitation Project, where the said elementary school stands is located in Sitio Pinasahl, which was originally within the geographical territory of Barangay Mansilingan;

WHEREAS, the Mansilingan Relocation and Rehabilitation Project became the first phase of the resettlement area for the squatters in Bacolod City, later known as "Handumanan", meaning "souvenir" or "legacy" in the local dialect, and which has grown and developed considerably through the years in terms of land area, population, roads and other infrastructure facilities and services and which now includes Phase I (MRRP), Phase II (MSSP), Phase III, Phase IV, Phase V, Phase VI-A and Phase VI-B;

WHEREAS, although Handumanan became a Chartered Barangay in 1985 by virtue of City Ordinance No. 09, Series of 1985, yet the school continues to carry the name of Barangay Mansilingan up to date;

WHEREAS, there is a need to change the name of Mansilingan Relocation and Rehabilitation Project Elementary School to Handumanan Elementary School for legal, geographic, economic and political reasons;

WHEREAS, the renaming of the MRRP Elementary School to Handumanan Elementary School is upon the request of the MRRP Elementary School Administration, Parents & Teachers & Community Association (PTCA), the Handumanan Barangay Council and recommendation of the Bacolod City School Board, upon consultation with the National Historical Institute.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

SECTION 1 - The name of Mansilingan Relocation and Rehabilitation Project Elementary School located at Barangay Handumanan, Bacolod City, be changed and renamed as Handumanan Elementary School.

SECTION 2 - This ordinance shall take effect immediately upon its approval .




