CITY ORDINANCE NO. 305

June 20, 2002

AN ORDINANCE ALLOWING ALJIS-CENTRAL MARKET PUBLIC UTILITY JEEPNEYS (PUJs) TO TAKE THE ROUTE TO JOHN B. LACSON COLLEGES FOUNDATION - BACOLOD (JBLCF-B) AS PART OF THEIR VIA ROUTE.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

WHEREAS, there is a need to allow PUJs to pass the via route going to John B. Lacson Colleges Foundation due to the increasing number of students and residents in the area;

WHEREAS, presently, Public Utility Jeeps (PUJs) are unable to enter the route directly going to John B. Lacson Colleges Foundation because of the clamors and, at times, harassment of tricycle drivers in the said area;

WHEREAS, it has always been the request of the populace of John B. Lacson Colleges Foundation and the surrounding communities to grant permission for the Public Utility Vehicles (PUJs) with Aljis-Central Market signboard to include the road going to the school in their via routes;

WHEREAS, this will give an alternative for the populace to choose whether to employ the services of PUJs or tricycles with consideration to their budget and convenience;

WHEREAS, drivers of both the PUJs and tricycle could both be given equal chances to earn their living;

Section 1 - TITLE. This ordinance shall be known as "An ordinance allowing Aljis-Central Market Public Utility Jeeps (PUJs) to take the route to John B. Lacson Colleges Foundation - Bacolod (JBLCF-B) as part of their via route.

Section 2 - EFFECTIVITY. This ordinance shall take effect immediately upon its approval.
