CITY ORDINANCE NO. 337

September 4, 2003

**AN ORDINANCE ALLOCATING 5% OF THE 20% DEVELOPMENT FUND FOR PROGRAMS AND PROJECTS FOR THE BENEFIT OF THE SENIOR CITIZENS OF BACOLOD CITY.**

**WHEREAS**, the Senior Citizens of Bacolod City comprises of about 7% of the city's population;

**WHEREAS**, RA 7432 obliges Senior Citizens to contribute to nation-building;

**WHEREAS**, to meet said call, there is need to allocate resources of the City for projects and programs of the Senior Citizens;

**WHEREAS**, the Executive Budget every year proposes a lump sum 20% as Development fund;

**WHEREAS**, a particular allocation for Senior Citizens will place them in equal footing with the youth sector and the other sectors.

Be it ordained by the Sangguniang Panglungsod of Bacolod, that:

**Section 1** - There shall be allocated in each Fiscal Year for the next five (5) years upon approval of this Ordinance, an amount equivalent to 5% of the total amount due as 20% Development Fund, for projects; programs and activities for the welfare of and to encourage participation by Senior Citizens in nation-building;

**Section 2** - The program of work for said project, program and activities shall be prepared by the Office of the Senior Citizens Affairs, to be submitted as part of the Annual Investment Plan for that particular year.

**Section 3** - This ordinance shall take effect upon its passage and approval.


