



CITY ORDINANCE NO. 340

October 2, 2003

AN ORDINANCE NAMING A DONATED PARCEL OF LAND PARTICULARLY PORTION OF LOT NO. 990 OF THE BACOLOD CADASTRE SITUATED IN BARANGAY FELISA CONTAINING AN AREA OF 100,000 SQUARE METERS AS VERAGUTH MONTILLA BARRIO HOMESITE.

WHEREAS, on February 17, 1958, Mrs. Bonifacia M. Vda De Veraguth in her goodness and generosity had donated to the City of Bacolod a parcel of land particularly portion of Lot No. 990 of the Bacolod Cadastre, situated in Brgy. Felisa, Bacolod City, containing an area of 100,000 square meters;

WHEREAS, it was the desire of the donor (Mrs. Bonifacia M. Vda. De Veraguth) to provide the Donee (City of Bacolod) of adequate homelots for the benefit of the bonafide residents of then Barrio Homesite in Barrio Mansilingan now known as Brgy. Felisa;

WHEREAS, one of the conditions imposed by the Donee upon the Donor, as stipulated in the Deed of Donation requires the naming of the barrio homesite as "Veraguth Montilla Barrio Homesite";

WHEREAS, Brgy. Res. No. 19, Series of 2003 has been passed by the Brgy. Council of Brgy. Felisa, requesting the Sangguniang Panlungsod to pass an ordinance naming the said Barrio Homesite as Veraguth Montilla Barrio Homesite;

WHEREAS, to give honor, recognition and in accordance with the desire of the Donee;

NOW THEREFORE, be it ordained by the Sangguniang Panlungsod of the City of Bacolod in Session assembled that:

ARTICLE I

Section I - The name of the Barrio Homesite consisting of a donated parcel of land particularly portion of Lot No. 990 of the Bacolod Cadastre situated in Brgy. Felisa containing an area of 100,000 square meters shall be "VERAGUTH MONTILLA BARRIO HOMESITE".

Section II - This ordinance shall take effect immediately upon its approval.
