CITY ORDINANCE NO. 348
November 20, 2003

AN ORDINANCE EXEMPTING THE VICE MAYOR'S LEAGUE OF THE PHILIPPINES-NEGROS OCCIDENTAL CHAPTER FROM THE PAYMENT OF AMUSEMENT TAX AND SUCH OTHER RELATED TAXES FOR SPONSORING A 5-COCK DERBY TO BE HELD ON DECEMBER 15, 16 AND 17, 2003 FOR THE BENEFIT OF THEIR ONGOING PROJECTS, PER LETTER-REQUEST OF VICE MAYOR SEVERO A. PALANCA, VICE PRESIDENT AND CHAIRMAN, DERBY COMMITTEE, DATED NOVEMBER 18, 2003 AND DOCKETED AS SP CORRESPONDENCE NO. 03-1247.

Be it ordained by the Sangguniang Panlungsod of the City of Bacolod in regular session assembled that

Section 1. - The Vice Mayor's League of the Philippines-Negros Occidental Chapter is hereby exempted from the payment of amusement tax and such other related taxes for sponsoring a 5-cock derby to be held on December 15, 16 and 17, 2003 for the benefit of their ongoing projects, per letter request of Vice Mayor Severo A. Palanca, Chairman, Vice President and Chairman, Derby Committee, dated November 18, 2003 and docketed as SP Correspondence No. 03-1247.

Section 2. This ordinance shall take effect upon its approval.
