CITY ORDINANCE NO. 349

November 27, 2003

AN ORDINANCE EXEMPTING THE NEGROS ASSOCIATION OF CHIEF EXECUTIVES, INC. FROM THE PAYMENT OF AMUSEMENT TAX AND SUCH OTHER RELATED TAXES FOR HOLDING A 5-COCK FUND RAISING DERBY ON JANUARY 8, 9 AND 10, 2004 FOR THE BENEFIT OF THE NEGROS ACE PROJECTS, PER LETTER-REQUEST OF HONORABLE FORTUNATO "BING" JAVELOSA, MAYOR OF SAGAY CITY AND TREASURER, NEGROS ACE, DATED NOVEMBER 25, 2003, DOCKETED AS SP CORRESPONDENCE NO. 03-1272.

Be it ordained by the Sangguniang Panglungsod of Bacolod, that:

**Section 1** - The Negros Association of Chief Executives, Inc. is hereby exempted from the payment of amusement tax and such other related taxes for holding a 5-cock fund raising derby on January 8, 9 and 10, 2004 for the benefit of the Negros ACE Projects, per letter-request of Honorable Fortunato "Bing" Javelosa, Mayor of Sagay City and Treasurer, Negros ACE, dated November 25, 2003, docketed as SP Correspondence No. 03-1272."

**Section 2** - This ordinance shall take effect upon its approval.


