**CITY ORDINANCE NO. 359**

**AN ORDINANCE GRANTING THE REQUEST OF THE UNIVERSITY OF ST. LA SALLE TO PAY A FIVE PERCENT (5%) AMUSEMENT TAX ON THE CONCERT OF KUNDIRANA AND THE PHILIPPINE OLDEST MARIAN IMAGE, THE NUESTRA SEÑORA DE GUIA (1571) ON FEBRUARY 21, 2004 FOR THE BENEFIT OF BAHAY PAG-ASA CENTER AND THE CONSTRUCTION OF BALAY KALINUNGAN PRAYER PAVILLON, PER LETTER OF BROTHER GUS BOQUER, FSC, EDD, DOCKETED AS SP CORRESPONDENCE NO. 04-71.**

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

**Section 1** - The request of the University of St. La Salle to pay a five percent (5%) amusement tax on the concert of Kundirana and the Philippine Oldest Marian Image, the Nuestra Señora de Guia (1571) on February 21, 2004 for the benefit of Bahay Pag-asa Center and the construction of Balay Kalinungan Prayer Pavilion is hereby granted, per letter of Brother Gus Boquer, FSC, EDD, docketed as SP Correspondence No. 04-71.


