CITY ORDINANCE NO. 361
February 12, 2004

AN ORDINANCE AMENDING CERTAIN SECTIONS OF CITY ORDINANCE NO. 290, SERIES OF 2001, KNOWN AS "AN ORDINANCE ESTABLISHING SERVICE FEE FOR LABORATORY AND ANCILLARY SERVICES".

WHEREAS, the Sangguniang Panlungsod of Bacolod City has already approved City Ordinance No. 290, series of 2001:

WHEREAS, in Section III, Article No. 12, there is no mention of Radiologist fee, wherein the city could not afford to hire a Radiologist, however, the same could be done on contractual basis;

WHEREAS, Section III did not include Dental Fees that is necessary for our Dental Department to operate continuously;

NOW THEREFORE, BE IT ORDAINED by the Sangguniang Panlungsod of the City of Bacolod in regular session assembled that:

Section 1. Article 12, Section III of City Ordinance No. 290, Series of 2001, is hereby amended to read as follows, to wit:

Section 2. There shall be added fees for the following Dental Fees to be designated as Article No. 14, in Section III of City Ordinance No. 290, series of 2001, to read as follows, to wit:




