CITY ORDINANCE NO. 372
September 16, 2004

AN ORDINANCE CORRECTING A TYPOGRAPHICAL ERROR IN ARTICLE 6, CHAPTER IV OF CITY ORDINANCE NO. 313, OTHERWISE KNOWN AS THE ENVIRONMENT CODE OF BACOLOD CITY.

WHEREAS the second sentence of Article 6, Chapter IV of City Ordinance 313 otherwise known as the Environment Code of Bacolod City provides:

"A violation of this provision shall be penalized with a maximum fine of P5,000.00 and/or a maximum imprisonment of a maximum of one year per count, that is, per illegal drilling or well, or both at the discretion of the court under the same guidelines as are set forth in Section 1(b) of Article 9, hereof."

WHEREAS, the "9" in the mention of "Article 9" is a simple typographical error, which should have been Article "7" instead of 9, as Chap. IV of the said Code is only up to Article 8 and has no Article 9.

NOW THEREFORE, be it ordained by the Sangguniang Panglungsod in session assembled, that

Section 1.- The number "9" after "Article", with the number "7" in the last sentence of Article 6, Chapter IV of City Ordinance No. 313 otherwise known as the "Environment Code of Bacolod City" is hereby corrected to read as follows, to wit:

"...under the same guidelines as are set forth in Section 1 (b) of Article 7 hereof."

Section 2.- That since this is only a correction of a typographical error, this corrective ordinance shall take effect upon its approval.


