CITY ORDINANCE NO. 377
November 25, 2004

AN ORDINANCE EXEMPTING THE NEGROS ASSOCIATION OF CHIEF EXECUTIVES, INC. (NEGROS-ACE) FROM THE PAYMENT OF AMUSEMENT TAXES FOR HOLDING A 5-COCK DERBY ON JANUARY 4, 5, 6 AND 8, 2005 AT THE NEGROS COLISEUM, RECLAMATION AREA, BACOLOD CITY IN CONNECTION WITH THE INTENDED VARIOUS PROJECTS OF THE ASSOCIATION, PER LETTER-REQUEST OF HONORABLE FORTUNATO JAVELOSA, MAYOR, SAGAY CITY AND TREASURER OF NEGROS-ACE, DOCKETED AS SP CORRESPONDENCE NO. 04-975.

Be it ordained by the Sangguniang Panlungsod of the City of Bacolod in regular session assembled that:






