CITY ORDINANCE NO. 383  
January 26, 2005

AN ORDINANCE APPROVING THE REQUEST OF MR. JANBY M. LEGASPI OF BAGGY PRODUCTIONS TO REDUCE THE AMUSEMENT TAX FROM THIRTY PERCENT (30%) TO FIVE PERCENT (5%) ON THE CONCERT ENTITLED, "PINOY IDOLS-BATTLE OF THE POPSTARS, LIVE IN BACOLOD" TO BE HELD ON JANUARY 29, 2005, 8:00 P.M. AT THE ST. LA SALLE COLISEUM, BACOLOD CITY, FOR THE BENEFIT OF THE HOLY FAMILY FOUNDATION, INC., A CHARITABLE INSTITUTION DULY ACCREDITED BY THE SANGGUNIANG PANLUNGSOD AND A DSSD PARTNER AS FAR AS WOMEN AND CHILDREN PROTECTION ARE CONCERNED, *SUBJECT TO A COLATILLA THAT BAGGY PRODUCTION SUBMITS A REPORT TO THE SANGGUNIANG PANLUNGSOD A WEEK AFTER THE CONCERT OF THE AMOUNT GIVEN TOGETHER WITH THE OFFICIAL RECEIPT FROM THE BENEFICIARY OF THAT PARTICULAR CONCERT.*

Be it ordained by the Sangguniang Panlungsod of the City of Bacolod in regular session assembled that:

**Section 1.** The request of Mr. Janby M. Legaspi of Baggy Productions to reduce the amusement tax from thirty percent (30%) to five percent (5%) on the concert entitled "PINOY IDOLS-BATTLE OF THE POPSTARS, LIVE IN BACOLOD" on January 29, 2005, 8:00 P.M. at the St. La Salle Coliseum, Bacolod City, for the benefit of the Holy Family Foundation, Inc., a charitable institution duly accredited by the Sangguniang Panlungsod and a DSSD partner as far as women and children protection are concerned, *subject to a colatilla that Baggy Production submits a report to the Sangguniang Panlungsod a week after the concert of the amount given together with the official receipt from the beneficiary of that particular concert.*

**Section 2.** The City Treasurer's Office is likewise requested to submit a report to the Sangguniang Panlungsod with regards to the affair and actual sales of tickets for purposes of information and guidance of the members

**Section 3.** This ordinance shall take effect upon its approval.
