



CITY ORDINANCE NO. 396

December 8, 2005

AN ORDINANCE ESTABLISHING THE BACOLOD SANGGUNIANG KABATAAN YOUTH CENTER AND DESIGNATING IT AS THE OFFICIAL OFFICE OF THE SK FEDERATION OF BACOLOD CITY.

WHEREAS, the Sangguniang Kabataan Federation of Bacolod City, a government entity composed of all the 61 SK Chairpersons and their councils, should have a place wherein to conduct its official business, convene and assemble for whatever activities and programs it may have for the youth;

WHEREAS, the Sangguniang Kabataan Federation of Bacolod City was the recipient of the Multi-Purpose Building located at Barangay 16, Reclamation Area, Bacolod City funded by Rep. Joel Villanueva of the Citizen's Battle Against Corruption (CIBAC) Party List; that the construction of the said building was completed in 2004 and was turned-over to the SK Federation of Bacolod City by the City Government of Bacolod, CIBAC, and DPWH during the same year;

WHEREAS, under Article 18 of City Ordinance No. 378, series of 2004 otherwise known as the "Child, Youth and Family Welfare and Development Code of Bacolod City", stipulates that in order for the youth and the Sangguniang Kabataan to be able to effectively attain the purposes of this Code, the City Mayor shall ensure the sustained operations of the Youth Center which shall, among others, house the SK Federation Office, and where activities and programs for the youth may be undertaken;

WHEREAS, the SK Federation of Bacolod City, during its 2nd Bacolod SK Convention held on February 2005, has passed a resolution to institutionalize the Bacolod SK Youth Center; that the current batch of officers and members of the SK Federation of Bacolod City takes pride of the Bacolod SK Youth Center as its legacy for the youth of the City; that it shall serve as an initial endeavor of the Sangguniang Kabataan in Bacolod City towards the fulfillment of its dream to provide our youth the center they can call their own; that the SK of today is committed at professionalizing its services for the youth and make the SK relevant in the city, that continues improvement of the center is needed in order to make it operational in service of our youth.

NOW THEREFORE, be it ordained, as it is hereby ordained by the Sangguniang Panlungsod of the City of Bacolod in session assembled that.

TITLE

AN ORDINANCE ESTABLISHING THE BACOLOD SANGGUNIANG KABATAAN YOUTH CENTER AND DESIGNATING IT AS THE OFFICIAL OFFICE OF THE SK FEDERATION OF BACOLOD CITY.

It shall also be known for its short title as "SK YOUTH CENTER" ORDINANCE.

Section 1 - Bacolod SK Youth Center

The Bacolod City SK Youth Center is the official office of the Sangguniang Kabataan Federation of Bacolod City and which shall serve as the official center of the activities and programs of the SK Federation for the youth in the city.

Section 2 - Location

The Bacolod SK Youth Center is located at Barangay 16, Reclamation Area, Bacolod City. It is beside the Senior Citizen's Center of Bacolod City.

Section 3 - Implementation

The Bacolod SK Youth Center shall be under the stewardship of the SK Federation of Bacolod City which shall undertake the management functions of but not limited to planning, programming, staffing, supervising, budgeting to ensure smooth operation of the center.

Section 4 - Basic Utilities

Basic utilities for the Bacolod SK Youth Center for light, water and telephone shall be provided for and maintained by the City Government necessary to operate the center.

Section 5 - Budget

The City Government shall allocate in the Annual Budget an amount not less than Two Hundred Thousand Pesos (P200,000.00) for the cost of personal services, maintenance and operating expenses other than that provided in Section 4 of this Ordinance, starting year 2006 and every year thereafter. The said amount may be increased upon the need in the future.

Section 6 - Separability Clause

If for any reason or reasons, any part or provision of this Ordinance shall be held to be unconstitutional or invalid by competent authority, other parts or provisions that are not affected thereby shall continue to be in full force and effect.

Section 7 - Repealing Clause

All ordinances, resolutions and executive orders and other issuances that are inconsistent with any provisions of this Ordinance are hereby repealed or modified accordingly.

Section 8 - Effectivity Clause

This Ordinance shall be effective immediately upon its approval.




