CITY ORDINANCE NO. 405
April 11, 2008

AN ORDINANCE AMENDING SECTION 1 OF THE CITY ORDINANCE NO. 337, SEPTEMBER 4, 2003 ALLOCATING 5% OF THE 20% DEVELOPMENT FUND FOR THE PROGRAMS AND PROJECTS FOR THE BENEFIT OF THE SENIOR CITIZENS OF BACOLOD CITY.

WHEREAS, Republic Act No. 7876, provides for the establishing a Senior Citizens center in all cities and municipalities of the Philippines and appropriating funds therefore;

WHEREAS, a Memorandum of Agreement (MOA) was entered into by and between the Regional Director, Department of Social Welfare and Development, City Mayor Evelio R. Leonardia and the Federation of Senior Citizens of Bacolod City (FESCAB) dated 25 of September, 1996, where the parties have agreed to fully support the implementation of Senior Citizens Center, as a focal point in the delivery of needed services for Senior Citizens,

WHEREAS, under Implementing Rules and Regulations of R.A. 7876, Rule III, Article 6, provides, there shall be established a Senior Citizens Center hereinafter referred to in this Act as the center, in every city and municipality of the Philippines. With the devolution of DSWD programs and services as well as personnel of the regional / field offices to the LGU cities and municipalities shall be called upon to provide administrative, support and supervision to the Senior Citizen Center which shall be administrated, managed and operated by the Federation of Senior Citizen Association of the Philippines,

WHEREAS, under Rule IX, Section 17 of the said Implementing Rules and Regulation, the amount necessary to carry out the provision of this Act shall be the amount necessary for the continuous operation of the center as well as the implementation of program and services for the elderly constituents shall be secured from the appropriation of the Local Government Units concerned

NOW THEREFORE, BE IT ORDAINED by the Sangguniang Panlungsod of the City of Bacolod in regular session assembled to amend Section 1 of City Ordinance No. 337, of September 4, 1996, so that as amended the same shall read as follows:

Section 1. There shall be allotted in each Fiscal Year for the next ten (10) years upon approval of this amended ordinance, an amount of 25% of the amount due from the 5% of the 20% of the Development Fund of the City Annual Investment fund as financial assistance to the Senior Citizens Center for projects, program, activities and administrative operation of the center by the Federation of Senior Citizen Association of Bacolod City.

Section 2. This ordinance shall take effect upon its approval.




