CITY ORDINANCE NO. 410  
August 24, 2006

AN ORDINANCE AMENDING SECTION 3, 3.1, 3.3.1, SECTION 7 AND SECTION 8 OF CITY ORDINANCE NO. 406, MAY 25, 2006, 'AN ORDINANCE IMPOSING CONDITIONS REQUIRED FOR THE CONSTRUCTION OF OUTDOOR SIGNS AND BILLBOARD ADVERTISING SIGNS BY THE NATIONAL BUILDING CODE OF THE PHILIPPINES (P.D. 1096) WITHIN THE JURISDICTION OF BACOLOD CITY PRIOR TO THE ISSUANCE OF BUILDING PERMIT, PROVIDING PENALTIES AND FOR OTHER PURPOSE.

**WHEREAS**, Bacolod City has already an existing and approved zoning map that classifies residential, commercial and industrialize zones.

**WHEREAS**, the said zoning map shall be the basis for approval for any signs structures that may be constructed or erected in the City of Bacolod.

**NOW THEREFORE**, be it ordained by the Sangguniang Panlungsod of the City of Bacolod in regular session assembled that:

**Section 1.** The following amendments are hereby made on City Ordinance 406, Series of 2006, as follows:

**Section 3, 3.1** Signs structures may be constructed only in commercial and industrial zones as approved in the zoning map of the City of Bacolod and in accordance with the accepted standards of design, construction and maintenance.

**Section 3, 3.3.1** Ground signs and advertising ground signs, which shall be constructed in conformity with accepted engineering standards of which height control shall be governed by the provisions of Section 6 of this ordinance.

**Section 7.**

7. The necessary business permits to conduct business in Bacolod City.
8. Clearance from the Outdoor Advertising Association of the Philippines (OAAP) Bacolod Chapter, certifying the billboard's compliance to the OAAP code of ethics for advertising.

**Section 8.**

8.4 Locational/Zoning Fee

P100,000 and below	- P1,000.00
Over P100,000.00	- P1,000.00 + 1/10 of 1% Of cost in excess of P100,000.00.

**Section 2.** This ordinance shall take effect upon its approval according to law.


