



CITY ORDINANCE NO. 418

November 9, 2006

AN ORDINANCE APPROVING THE REQUEST OF HONORABLE MARXLENE DE LA CRUZ, VICE MAYOR, MUNICIPALITY OF DS BENEDICTO AND CHAIRMAN, DERBY COMMITTEE, TO EXEMPT THE VICE MAYOR'S LEAGUE OF THE PHILIPPINES-NEGROS OCCIDENTAL CHAPTER FROM THE PAYMENT OF AMUSEMENT TAX AND SUCH OTHER RELATED TAXES ON A 4-COCK DERBY SPONSORED BY THE LEAGUE TO BE HELD ON DECEMBER 1, 2 AND 3, 2006, PROCEEDS OF SAID ACTIVITY WILL BE FOR THE ON-GOING MEDICAL, SURGICAL, DENTAL, THERAPEUTIC AND HAIRCUT MISSION AND OTHER PROJECTS OF THE LEAGUE, DOCKETED AS SP CORRESPONDENCE NO. 06-989.

Be it ordained by the Sangguniang Panglungsod of Bacolod, that:

Section 1 - The request of the Vice Mayor's League of the Philippines-Negros Occidental Chapter to exempt from the payment of amusement tax and such other related taxes on a 4-cock derby sponsored by the league to be held on December 1, 2 and 3, 2006, is hereby approved, proceeds of said activity will be for the on-going medical, surgical, dental, therapeutic and haircut mission and other projects of the league, per letter-request of Honorable Marxlene de la Cruz, Vice Mayor, Municipality of DS Benedicto and Chairman, Derby Committee, docketed as SP Correspondence No. 06-989.


