CITY ORDINANCE NO. 437
April 26, 2007

AN ORDINANCE APPOINTING THE SANGGUNIANG KABATA-AN MEMBERS AS COUNTERPART OF THE CITY MAYOR, CITY VICE-MAYOR AND MEMBERS OF THE SANGGUNIANG PANLUNGSOD DURING THE OBSERVANCE OF THE LINGGO NG KATIPUNAN NG KABATA-AN IN THE CITY OF BACOLOD.

WHEREAS, under Section 439 (b) of R.A. 7160, otherwise known as Local Government Code of 1991, states that "the observance of the Linggo ng Kabata-an shall include the election of the counterparts of all elective and appointed local officials, as well as heads of national offices or agencies stationed or assigned in the territorial jurisdiction of the LGU, among in-school and community youth residing in the LGU...;

WHEREAS, Resolution No. 965, Series of 2005, declaring December 17 to 21, 2005 as Linggo ng Katipunan ng Kabata-an in the City of Bacolod;

WHEREAS, the Sangguniang Kabata-an should be given a chance and opportunity to exercise their leadership, their managerial skills, enhance their social, political, economic, cultural, intellectual and moral capabilities of the SK; by allowing them to act as City Officials during the duration of Linggo ng Kabata-an.

NOW, THEREFORE, be it ordained by the Sangguniang Panlungsod of Bacolod in session assembled that:

Article I. TITLE. Ordinance appointing the Sangguniang Kabata-an Members as counterpart of the City Mayor, City Vice-Mayor and Members of the Sangguniang Panlungsod during the observance of the Linggo ng Katipunan ng Kabata-an in the City of Bacolod.

Article II SELECTION OR ELECTION OF THE COUNTERPART OFFICIALS. The SK Federation shall adopt the mechanics in the manner of selection or election.

Article III QUALIFICATION OF CANDIDATES. Bona fide members of the Sangguniang Kabata-an duly certified by the SK Chairman of their respective barangays.

Article IV OATH OF CANDIDATES. The City Mayor or his authorized representative will conduct the oath taking at the Fountain of Justice to be attended by the City Officials, Department Heads, Sangguniang Kabata-an Members and quests in an appropriate ceremony.

Article V TENURE OF OFFICE AS COUNTERPART OFFICIAL. The Sangguniang Kabata-an Members who had been elected and appointed as counterparts of the City Official will hold office only during the duration of the celebration of the Linggo ng Katipunan ng Kabata-an.

Those who had served and appointed as counterpart official as Mayor and Vice-Mayor can no longer run for the same position in the next Linggo ng Kabata-an; except those appointed or elected as Sangguniang Panlungsod Members.

Article VI RECOGNITION. In recognition of the services rendered by the Sangguniang Kabata-an, the City Officials will present a Certificate of Appreciation among other incentives.

Article VII EFFECTIVITY. This Ordinance shall take effect fifteen (15) days after its publication in a newspaper of local circulation.
