CITY ORDINANCE NO. 439  
June 7, 2007

AN ORDINANCE APPROVING THE REQUEST OF THE UNIVERSITY OF ST. LA SALLE BACOLOD ALUMNI FOUNDATION, INC. TO REDUCE THE PAYMENT OF THE AMUSEMENT TAX FROM 30% TO FIVE (5) PERCENT ONLY ON THEIR CONCERT FEATURING "THE ASSOCIATION" BACK-TO-BACK WITH "CHAD AND JEREMY" ON JUNE 17, 2007 AT THE USLS COLISEUM FOR THE BENEFIT OF BAHAY PAG-ASA YOUTH CENTER, AND AN ALUMNI CLASS '57 DANCE/CONCERT FEATURING THE BAND "BEHIND CLOSED DOORS" ON JULY 6, 2007 AT THE SANTUARIO DE LA SALLE FOR THE BENEFIT OF FR. GRATIAN'S BACOLOD BOY'S HOME, PER LETTER OF "JOSE CUGIE" N. LOARCA, SECRETARY, DATED JUNE 1, 2007", AND DOCKETED AS SP CORRESPONDENCE NO. 07-352.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section 1.- The request of the University of St. La Salle Bacolod Alumni Foundation, Inc. to reduce the payment of the amusement tax is hereby approved from 30% to Five (5) percent only on their CONCERT FEATURING "THE ASSOCIATION" BACK-TO-BACK WITH "CHAD AND JEREMY" ON JUNE 17, 2007 AT THE USLS COLISEUM FOR THE BENEFIT OF BAHAY PAG-ASA YOUTH CENTER, AND AN ALUMNI CLASS '57 DANCE/CONCERT FEATURING THE BAND "BEHIND CLOSED DOORS" ON JULY 6, 2007 AT THE SANTUARIO DE LA SALLE FOR THE BENEFIT OF FR. GRATIAN'S BACOLOD BOY'S HOME", per letter of "Jose Cugie" N. Loarca, Secretary, dated June 1, 2007", and docketed as SP Correspondence No. 07-352.

Section 2. - This Ordinance shall take effect upon its approval.




