CITY ORDINANCE NO. 444
September 26, 2007

AN ORDINANCE APPROVING THE REQUEST OF MS. CARISSA DELEON-MAALAT, GENERAL MANAGER OF THE BACOLOD PAVILLON RESORT HOTEL RESTAURANT, TO REDUCE THE PAYMENT OF THE AMUSEMENT TAX FROM THIRTY PERCENT (30%) TO FIVE PERCENT (5%) ONLY FOR THE POWER PICK PRODUCTION STAGING OF A PRE MASSKARA ROCK FESTIVAL, A BAND CONCERT ON OCTOBER 12, 2007 AND MR. MASSKARA BODY BUILDING COMPETITION ON OCTOBER 20, 2007 AT THE BACOLOD PAVILLON RESORT HOTEL RESTAURANT WHICH WILL BE FOR THE BENEFIT OF THE SAN SEBASTIAN CATHEDRAL LECTOR'S MINISTRY, PENDING ACCREDITATION OF THE SAID BENEFICIARY, AND DOCKETED AS SP CORRESPONDENCE NO. 07-803.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section 1 - The request of Ms. Carissa Deleon-Maalat, General Manager of the Bacolod Pavillon Resort Hotel Restaurant, to reduce the payment of the amusement tax from Thirty Percent (30%) to Five Percent (5%) only for the Power Pick Production staging of a Pre Masskara Rock Festival, a band concert on October 12, 2007 and Mr. Masskara Body Building Competition on October 20, 2007 at the Bacolod Pavillon Resort Hotel Restaurant is hereby approved, the proceeds of which will be for the benefit of the San Sebastian Cathedral Lector's Ministry, pending accreditation of the said beneficiary, and docketed as SP-Correspondence No. 07-803.

Section 2 - This ordinance shall take effect upon its approval.


