CITY ORDINANCE NO. 446  
October 3, 2007

AN ORDINANCE APPROVING THE REQUEST OF MR. JAKE CASTELLANO, VICE PRESIDENT OF BACOLOD CITY GOVERNMENT EMPLOYEES UNION (BCGEU) FOR A REDUCTION OF PAYMENT OF THE AMUSEMENT TAX FROM THIRTY PERCENT (30%) TO FIVE PERCENT (5%) ONLY FOR THE STEVE O'NEAL PRODUCTIONS STAGING OF "JOHN FORD COLEY JUST TELL ME YOU LOVE ME CONCERT" ON OCTOBER 14, 2007 AT THE UNIVERSITY OF ST. LA SALLE (USLS) COLISEUM FOR THE BENEFIT OF THE BACOLOD CITY GOVERNMENT EMPLOYEES UNION (BCGEU), PER LETTER ENDORSEMENT OF HONORABLE CITY MAYOR EVELIO R. LEONARDIA, DATED OCTOBER 1, 2007 AND DOCKETED AS SP CORRESPONDENCE NO. 07-817-A.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

**Section 1** – The request of Mr. Jake Castellano, Vice President of Bacolod City Government Employees Union (BCGEU) for a reduction of payment of the amusement tax from Thirty Percent (30%) to Five Percent (5%) only for the Steve O'Neal Productions staging of "John Ford Coley Just Tell Me You Love Me Concert" on October 14, 2007 at the University of St. La Salle (USLS) Coliseum is hereby approved, the proceeds of which will be for the benefit of the Bacolod City Government Employees Union (BCGEU), per letter endorsement of Honorable City Mayor Evelio R. Leonardia, dated October 1, 2007 and docketed as SP Correspondence No. 07-817-A.

**Section 2** – This ordinance shall take effect upon its approval.


