CITY ORDINANCE NO. 455
December 19, 2007

AN ORDINANCE EXEMPTING FROM THE PAYMENT OF AMUSEMENT TAX AND SUCH OTHER RELATED TAXES THE VICE MAYORS' LEAGUE OF THE PHILIPPINES, NEGROS OCCIDENTAL CHAPTER, FOR THE HOLDING OF 5-COCK FUND RAISING DERBY ON DECEMBER 27, 28 AND 29, 2007, PROCEEDS OF WHICH WILL BE FOR THE BENEFIT OF THE VMLP-NOC PROJECTS, PER LETTER-REQUEST OF THE HON. VICE MAYOR JOSELINO SANTIAGO OF THE MUNICIPALITY OF MURCIA, CHAIRMAN DERBY COMMITTEE, DOCKETED AS SP CORRESPONDENCE NO. 07-1021.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section 1 – The Vice Mayors' League of the Philippines, Negros Occidental Chapter, is hereby exempted from the payment of amusement tax and such other related taxes for the holding of 5-cock fund raising derby on December 27, 28 and 29, 2007, proceeds of which will be for the benefit of the VMLP-NOC Projects, per letter-request of the Hon. Vice Mayor Joselino Santiago of the Municipality of Murcia, Chairman Derby Committee, docketed as SP Correspondence No. 07-1021.

Section 2 – This ordinance shall take effect upon its approval.






