CITY ORDINANCE NO. 457
January 30, 2008

AN ORDINANCE AMENDING SECTION 4 BY ADDING ANOTHER SUB-SECTION 4.5 OF CITY ORDINANCE NO. 373, DATED SEPTEMBER 23, 2004, "AN ORDINANCE ESTABLISHING AND STRENGTHENING THE OFFICE OF THE SENIOR CITIZENS AFFAIRS (OSCA) IN THE CITY OF BACOLOD PROVIDING FUNDS THEREFOR AND FOR OTHER PURPOSES.

WHEREAS, Section 27, Rules and Regulations promulgated in pursuance to Section 12 of the Republic Act No. 9257, states "the necessary appropriation for the operation and maintenance of the OSCA shall be appropriated and approved by the Local Government concerned;

WHEREAS, Department of Social Welfare and Development in its opinion "that remuneration of the Head of OSCA and other operating expenses shall be appropriated and approved by the Local Government Unit";

WHEREAS, City Ordinance No. 337, dated September 4, 2003, "An Ordinance allocating 5% of the 20% development fund for programs and projects for the benefit of the Senior Citizens of Bacolod City".

NOW THEREFORE, be it ordained by the Sangguniang Panlungsod of the City of Bacolod in session assembled, that:

Section 1 – Section 4, of City Ordinance No. 373, dated September 23, 2004, is hereby amended by adding another Section 4.5 to be read as follows:

4.5 – Honorarium of the Office of the Senior Citizens Affair Head
(OSCA HEAD)

The position of the Head in the Office of Senior Citizens Affairs (OSCA) is a full time administrative job and needs all the attention, capabilities and working time of OSCA Head, which is also entitled to just compensation by way of honorarium at the rate of FIFTEEN THOUSAND PESOS (PHP15,000.000) a month to be taken from the budget appropriation provided for under Section 5 of the City Ordinance No. 373, dated September 23, 2004.

Section 2 – This ordinance shall take effect immediately upon its approval in accordance with law.




