CITY ORDINANCE NO. 458

January 30, 2008

AN ORDINANCE TEMPORARILY SUSPENDING THE EFFICACY OF EXISTING CITY ORDINANCES FOR THE ROUTING OF ALL CARGO TRUCKS FROM THE SOUTH GOING TO THE NORTH FOR A PERIOD OF FIFTY (50) DAYS EFFECTIVE JANUARY 31, 2008, SUBJECT TO CERTAIN COLATILLAS.

NOW THEREFORE, be it ordained by the Sangguniang Panlungsod of Bacolod City in session assembled, that:

Section 1 - The efficacy of existing city ordinances for the routing of all cargo trucks from the South going to the North is hereby suspended for a period of Fifty (50) days effective January 31, 2008, subject to the following colatillas, to wit.

1. That the Committee on Transportation together with all the stakeholders shall continuously study other alternative and more viable routes during the period;
2. To strictly enforce the measures against overloading of sugarcane and to disallow trucks in entering Bacolod City which have no proper signal lights and the sugarcanes are not properly stocked or piled.
3. That a report must be submitted to the Sangguniang Panlungsod after seven (7) days.

Section 2 - That the Bacolod Traffic Authority Office (BTAO) is hereby authorized to implement the attached new truck route effective January 31, 2008, docketed as SP Correspondence No. 08-142-A.

Section 3 - This ordinance shall take effect immediately upon approval.


