CITY ORDINANCE NO. 467
August 6, 2008

AN ORDINANCE REPEALING CITY ORDINANCE NO. 321, SERIES OF 2002, OTHERWISE KNOWN AS "AN ORDINANCE SETTING THE CEILING OF THE PERSONNEL COMPONENT OF ALL PROJECT FUNDS WITH PERSONNEL COMPLEMENT UNDER NON-OFFICE EXPENDITURES AND 20% DEVELOPMENT FUNDS AT 30% PER APPROVED PROJECT".

WHEREAS, the Honorable City Mayor Evelio R. Leonardia requested the Sangguniang Panlungsod through SP Correspondence No. 08-149 for the repeal of City Ordinance No. 321, series of 2002;

WHEREAS, the reason adduced thereto for the repeal of the aforesaid ordinance is the indubitable fact that there are projects that require 100% personnel component like garbage collection and disposal, street cleaning and clean and green project;

WHEREAS, aside from the above reason, there are programs and projects which are labor intensive and the 30% cap is no longer realistic vis-à-vis the recent implementation of the salary increase;

WHEREAS, the repeal of the City Ordinance No. 321, series of 2002, is in consonance to the 10-point agenda of the President that all local government units are enjoined to complement the programs on livelihood projects and employment opportunities; .

WHEREAS, the wisdom and discretion of the execution on how the budget is to be expended deserves respect and courtesy from a co-equal branch of government as part of his inherent power and authority.

NOW THEREFORE, BE IT ORDAINED AS IT IS HEREBY ORDAINED by the Sangguniang Panlungsod of Bacolod:

Section 1 – That City Ordinance No. 321 in its entirety is hereby repealed, withdrawn, and of no more force and effect.

Section 2 – That this repealing act shall at once become effective upon its approval.




