CITY ORDINANCE NO. 476  
December 22, 2008

AN ORDINANCE AMENDING SECTION 4 OF CITY ORDINANCE 466, DATED JUNE 30, 2008 ENTITLED "AN ORDINANCE REQUIRING MOTORCYCLE RIDERS INCLUDING TANDEM RIDERS TO WEAR CRASH OR SAFETY HELMET WHILE OPERATING ALONG CITY OF BACOLOD AND PROVIDING PENALTIES AND OTHER PURPOSES.

Be it ordained by the Sangguniang Pailungsod of Bacolod, that:

Section 1 – Section 4 of City Ordinance No. 466, June 30, 2008 is hereby amended and added – to read as follows:

Section 4 – violation of this Ordinance shall be penalized.

1<sup>st</sup> violation – citation ticket and fine of P150.00.

2<sup>nd</sup> violation – citation ticket and fine of P500.00.

3<sup>rd</sup> violation – suspension of drivers license for 30 days and fine of P1,000.00 and undergo seminar on Traffic Rules and Regulation with LTO or BTAO.

as amended and added.

Section 4 – Penalties in case of violation:

1<sup>st</sup> violation – issuance of citation ticket and fine of P150.00

2<sup>nd</sup> violation – issuance of citation ticket and fine of P500.00.

3<sup>rd</sup> violation – suspension of drivers license for 30 days, traffic citation/ticket and fine of P1,000.00 and will undergo seminar on Traffic Rules and Regulation with LTO or BTAO.

The corresponding penalties to be collected shall be distributed:

1. Thirty percent (30%) shall be allocated to Bacolod Traffic Authority Office (BTAO) for their traffic operation and incentives, more particularly on their uniform, traffic equipment, accident insurance, medication and other purposes, that the BTAO may approved except for the payment of salaries and wages.

The thirty percent (30%) can be disturbed upon the submission of the program of works by the Head of the BTAO duly approved by the City Mayor, in accordance with the provisions of the existing law.

- 2. Seventy percent (70%) shall form part of the General Fund of the City.

Section 2 - This ordinance shall take effect upon its publication in a newspaper of local circulation




