AN ORDINANCE DEFERRING/SUSPENDING THE IMPLEMENTATION OF CITY ORDINANCE NO. 474, SERIES OF 2008, OTHERWISE KNOWN AS THE REVISED REVENUE CODE OF BACOLOD CITY, PENDING THE REVIEW OF ITS PROVISIONS RELATIVE TO THE PROPOSED AMENDMENTS AS APPROVED ON FIRST READING LAST FEBRUARY 4, 2009, PER LETTER-REQUEST OF THE HONORABLE CITY MAYOR EVELIO R. LEONARDIA DATED FEBRUARY 10, 2009 AND DOCKETED AS SP CORRESPONDENCE NO. 09-66-E.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section 1 - The implementation of City Ordinance No. 474, series of 2008, otherwise known as the Revised Revenue Code of Bacolod City is hereby deferred/suspended pending the review of its provisions relative to the proposed amendments as approved on first reading last February 4, 2009, per letter-request of the Honorable City Mayor Evelio R. Leonardia dated February 10, 2009 and docketed as SP Correspondence No. 09-66-E.

Section 2 - This ordinance shall take effect upon its approval.






