**AN ORDINANCE GRANTING AUTHORITY TO THE MAYOR AND VICE MAYOR TO AUGMENT ANY ITEM IN THE APPROVED 2016 ANNUAL BUDGET OF THEIR RESPECTIVE OFFICES FROM SAVINGS IN OTHER ITEMS WITHIN THE SAME EXPENSE CLASS OF THEIR RESPECTIVE APPROPRIATIONS AS PROVIDED IN SECTION 336 OF THE LOCAL GOVERNMENT CODE, PER SP CORRESPONDENCE NO. 08-16-0099.**

Be it ordained by the Sangguniang Panlungsod of Bacolod, in session assembled, that:

**Section 1** – An authority is hereby granted to the Mayor and Vice Mayor to augment any item in the approved 2016 Annual Budget of their respective offices from savings in other items within the same expense class of their respective appropriations as provided in Section 336 of the Local Government Code, per SP Correspondence No. 08-16-0099.

**Section 2** – This ordinance shall take effect upon its approval.






