CITY ORDINANCE NO. 09-16-800

December 14, 2016

“AN ORDINANCE AUTHORIZING A TEMPORARY HALF ROAD CLOSURE APPROXIMATELY 40 METERS ALONG STA. ANA STREET ON DECEMBER 10-17, 2016 TO BE USED AS STREET FAIR AND SOUVENIR SHOP STALL IN LINE WITH THE 31ST CHARTER DAY CELEBRATION OF BARANGAY 30, BACOLOD CITY, SUBJECT TO REVOCATION OF THE SANGGUNIANG PANLUNGSOD IF THE SAME CAUSES CONGESTION AND INCONVENIENCE TO THE RESIDENTS IN THE AREA, AND PROVIDED FURTHER THAT THERE SHOULD BE STRICT COMPLIANCE OF THE ROAD CLOSURE ORDINANCE AND SUBSEQUENT INFORMATION-DISSEMINATION VISIBLE TO THE GENERAL PUBLIC BE POSTED A WEEK BEFORE THE SAID EVENT”.

**WHEREAS**, the Barangay will hold its 2<sup>nd</sup> De Colores Festival on December 10-17, 2016 in line with their 31<sup>st</sup> Charter Day;

**WHEREAS**, the MBF Transient Organizing Services will exhibit its products on December 10-17, 2016, as one of the highlights of their celebration;

**WHEREAS**, Barangay Resolution No. 16-208, Series of 2016, of Barangay 30, Bacolod City, requesting the City Government of Bacolod for the Approval of usage of a half lane along Sta. Ana Street, approximately 40 meters, to be used as street fair and souvenir shop stall;

**NOW THEREFORE**, be it **ORDAINED** as it is hereby **ORDAINED** by the Sangguniang Panlungsod in session assembled, that;

**Section 1. -- TEMPORARY HALF ROAD CLOSURE** – a temporary half road closure approximately 40 meters along Sta. Ana Street on December 10-17, 2016 to be used as street fair and souvenir shop stall in line with the 31st Charter Day Celebration of Barangay 30, Bacolod City, has been approved, provided that there should be strict compliance of the Road Closure Ordinance and subsequent information-dissemination visible to the general public be posted a week before the said event;

**Section 2. – SAFETY** – The Barangay shall ensure the safety of both motorists and pedestrians by putting up pre-cautionary measures at the site, and ensure the free-flow of traffic by assigning personnel to direct traffic thereat, any time of the day and night;

**Section 3. - FINAL PROVISION** - The City reserves the right to revoke the authority granted to Barangay 30, Bacolod City in case such occupation results to unbearable traffic congestion, unhealthy and unsanitary environment and other similar nuances, through a resolution duly passed and approved by the City Council;

**Section 4. - EFFECTIVITY** - This Ordinance shall take effect immediately upon its approval in accordance to law.
