CITY ORDINANCE NO. 02-14-665

March 19, 2014

AN ORDINANCE GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR AND VICE MAYOR TO AUGMENT ANY ITEM IN THE APPROVED 2014 ANNUAL BUDGET IN THEIR RESPECTIVE OFFICES FROM SAVINGS IN OTHER ITEMS WITHIN THE SAME CLASS OF THEIR RESPECTIVE APPROPRIATIONS.

WHEREAS, Section 336 of the Local Government Code of 1991 (Republic Act No. 7160) states, among others, "XXX the local chief executive or the presiding officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations" by way of exception that funds shall be available exclusively for the specific purpose for which they have been appropriated and the prohibition authorizing any transfer of appropriation from one item to another;

WHEREAS, in order to fast track implementation of policy directions, in the executive and legislative branches of the Local Government Unit, it is necessary to set in motion, section 336 of the Local Government Code of 1991.

WHEREFORE BE IT ENACTED, AS IT IS HEREBY ENACTED BY THE SANGGUNIANG PANLUNGSOD OF BACOLOD CITY IN SESSION ASSEMBLED THAT:

Section 1. Short Title: This ordinance shall be known as the "Augmentation Ordinance of 2014".

Section 2. Authority. This ordinance shall grant authority to the Honorable City Mayor Monico O. Puentevella and the Honorable Vice Mayor Greg G. Gasataya, to augment any item in the approved 2014 Annual Budget in their respective offices, concerned from savings in other item within the same class of their respective appropriations, as provided for in section 366 of RA 7160 or the Local Government Code of 1991.

Section 3. Limitation. This authority shall cover only the 2014 Annual Budget.

Section 4. Effectivity. This ordinance shall take effect upon its approval.


