CITY ORDINANCE NO. 581

February 29, 2012

**AN ORDINANCE AMENDING SECTION 5 OF CITY ORDINANCE NO. 505, OTHERWISE KNOWN AS AN ORDINANCE ESTABLISHING THE HIGHLY URBANIZED CITY AGRICULTURAL AND FISHERY COUNCIL (HUCAFC).**

**NOW THEREFORE BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF BACOLOD CITY, in session assembled, that:**

Section 5 of City Ordinance No. 505 is hereby amended and shall read as:

**Section 5. FUNDING ALLOCATION** – For the purpose of ensuring the successful implementation of the city's agricultural and fisheries program and projects through the facilitation of sound policy direction, and in subscription to the mandate of the national government, the amount of ONE MILLION PESOS (Php 1,000,000.00) shall be appropriated to the HUCAFC for every fiscal year.

The amount shall be utilized exclusively by the HUCAFC for their expenses, but not limited to the following:

- a. Agricultural and Fisheries Supplies;
- b. Agricultural and Fisheries Equipment;
- c. Office Supplies;
- d. Training Expenses;
- e. Traveling Expenses;
- f. Other Operating Expenses; and
- g. Other Professional Expenses

The amount to be appropriated by the City to HUCAFC shall be subject to submission of the appropriate program of works, detailed plan actions recommended by the Head of the City Department of Agriculture and approved by the City Mayor.

The proper accounting and auditing procedures shall be applied to all manner of the fund disbursements intended for HUCAFC.



**5.1 HONORARIA OF ALL HUCAF C OFFICERS.** All officers duly elected by the HUCAF C shall receive an honorarium in the amount of One Thousand Pesos (Php 1,000.00) every month to be taken from the annual budget appropriated to the HUCAF C by the City of Bacolod.

To avail of the honoraria, there must be a monthly meeting and a record of attendance must be attached by an officer claiming the same and must be duly attested and certified by the Chairman or Vice Chairman of the HUCAF C.


