CITY ORDINANCE NO. 628

December 27, 2012

AN ORDINANCE CREATING THE POSITIONS OF TWO (2) ADDITIONAL STENOGRAPHIC REPORTER IV, GRADE 13, STEP 1 AND TWO (2) ADDITIONAL STENOGRAPHIC REPORTER III, GRADE 11, STEP 1, UNDER THE STENOGRAPHIC SERVICES SECTION IN THE OFFICE OF THE SANGGUNIANG PANLUNGSOD, BACOLOD CITY, AND APPROPRIATING FUNDS THEREOF.

WHEREAS, at present there is a need to create the positions of two (2) Stenographic Reporter IV, G-13, S-1, and two (2) Stenographic Reporter III, Grade 11, Step 1 under the Stenographic Services Section in the Office of the Sangguniang Panlungsod, Bacolod City;

WHEREAS, the position title is in accordance with the Local Budget Circular No. 61, dated March 18, 1996, the Revised Index of Occupational Services, Positions Title and Salary Grade in the Local Government;

WHEREAS, the functions of said positions are to take down the proceedings and transcribe the Minutes and other stenographic jobs in the Stenographic Services Section of the Office of the Sangguniang Panlungsod.

Section 1. POSITIONS: That there is hereby created in the Office of the Sangguniang Panlungsod the positions of two (2) additional Stenographic Reporter IV, Grade 13, Step 1 and two (2) additional Stenographic Reporter III, Grade 11, Step 1.

Section 2. APPROPRIATION: That an amount shall be appropriated for the compensation and other emoluments and benefits for these newly created positions based on their respective salary grades to be taken from the annual appropriation of the city.

Section 3. EFFECTIVITY: This ordinance shall take effect upon its approval.






