CITY ORDINANCE NO. 1002
July 27, 2022

AN ORDINANCE AMENDING SECTION 1 OF ARTICLE 2 OF CITY ORDINANCE NO. 413 SERIES OF 2006, "AN ORDINANCE ESTABLISHING THE ARTS AND CULTURE COUNCIL OF BACOLOD CITY, AND MANDATING AN ANNUAL ARTS AND CULTURE PROGRAM IN THE CITY OF BACOLOD".

WHEREAS, the Amended Internal Rules of the Sangguniang Panlungsod (SP) provides for the creation of the SP Committee on Committee on History, Arts and Culture;

WHEREAS, there is a need to update City Ordinance No. 413, Series of 2006 to harmonize with the current composition of the city council;

NOW THEREFORE, be it **ORDAINED** as it is hereby **ORDAINED** by the Sangguniang Panlungsod in session assembled, that:

SECTION 1. Section 1 of Article 2 of City Ordinance No. 413, Series of 2006 which reads:

ARTICLE 2. THE ARTS AND CULTURE COUNCIL OF BACOLOD.

Section 1. Composition. There is hereby created a Council to be known as the **ARTS AND CULTURE COUNCIL** of BACOLOD CITY, or ACC for brevity, to be composed as follows:

- Chairman : The City Mayor or his designate who shall serve as such at the pleasure of the Mayor
- Vice-Chairman : The Chairman of the SP Committee on Tourism, Culture and History
- Members : The Chairman, SP Committee on Education
The Head of the Bacolod City Tourism Office
President of the Liga Ng Mga Barangay
President of the SK Federation
Representative from the Public Schools
Representative from the Private Schools preferably from the NOPSCEA
A representative from the Visual Arts group
A representative from Theater
A representative from Cinema
A representative from Dance
A representative from Music
A representative from Architecture
A representative from other performing arts

Shall be amended to read as:

ARTICLE 2. THE BACOLOD ARTS AND CULTURE COUNCIL.

Section 1. Composition. There is hereby created a Council to be known as the BACOLOD ARTS AND CULTURE COUNCIL, or BACC for brevity, to be composed as follows:

- Chairman : The City Mayor or his designate who shall serve as such at the pleasure of the Mayor
- Vice-Chairmen : Chairperson, SP Committee on History, Arts and Culture
Chairperson, SP Committee on Tourism
- Members : The Chairperson, SP Committee on Education
City Tourism Officer
President, Liga Ng Mga Barangay
President, Sangguniang Kabataan Federation
District Schools Superintendent
Representative from the Private Schools/NOPSSCEA
A representative from the National Commission for Culture and Arts
A representative from the Visual Arts group
A representative from Theater
A representative from Cinema
A representative from Dance
A representative from Music
A representative from Architecture
A representative from other performing arts
Others as may deem necessary

SECTION 2. EFFECTIVITY CLAUSE. This Ordinance shall take effect immediately upon its approval.






