CITY ORDINANCE NO. 1011
October 26, 2022

AN ORDINANCE AMENDING SEC. 5, C.O. NO. 868 OTHERWISE KNOWN AS “AN ORDINANCE DECLARING THE FIRST SATURDAY OF DECEMBER AS AN ANNUAL CELEBRATION OF CHRISTMAS FESTIVAL OF LIGHTS IN THE CITY OF BACOLOD, PROVIDING FUNDS THEREFOR AND FOR OTHER PURPOSES”.

WHEREAS, City Ordinance No. 868 of November 26, 2018 was envisioned to celebrate and sustain the birth of Christ, parading with lights, and music around the city serving as a symbol of hope of the Lord’s coming;

WHEREAS, it is discovered that the City Tourism Office was not included in the said City Ordinance;

WHEREFORE, LET IT BE ORDAINED AS IT IS HEREBY ORDAINED BY THE SANGGUNIANG PANLUNGSOD IN SESSION THAT:

Section 1. Section 5. of City Ordinance No. 868, which reads:

- Chairman : Mayor
- Vice-chairman : Chairman, SP Committee on Tourism

City Budget Officer
Head, Bacolod Traffic Authority Office
Negros Occidental Private Schools Sports Cultural and Educational Association (NOPSSCEA)
(1) One representative from business sector
(2) Two representatives from private schools
(2) Two representatives from public schools
(1) One representative from STI-West Negros University

SHALL BE READ AS:

Section 5. CREATION OF COMMITTEE. In implementing the intents of this Ordinance, there shall be created a Christmas Festival of Lights Committee (CFLC), the composition of which shall be as follows:



- Chairman : Mayor
- Vice-chairman : Chairman, SP Committee on Tourism
- Members : **City Tourism Office**

Department of Education Bacolod Schools Division Superintendent
City Budget Officer
Head, Bacolod Traffic Authority Office
Negros Occidental Private Schools Sports Cultural and Educational Association (NOPSSCEA)
(1) One representative from business sector
(2) Two representatives from private schools
(2) Two representatives from public schools
(1) One representative from STI-West Negros University


