RESOLUTION RESPECTFULLY REQUESTING THE CITY TREASURER'S OFFICE LICENSING DIVISION THROUGH HONORABLE CITY MAYOR ALFREDO ABELARDO B. BENITEZ TO STRENGTHEN THE IMPLEMENTATION REGARDING THE INSPECTION, TESTING, CALIBRATION, AND SEALING OF ALL FUEL PUMPS IN ALL GAS STATIONS IN THE CITY OF BACOLOD.

Upon motion of Councilor Claudio Jesus Raymundo A. Puentevella, seconded by Councilor Simplicia Z. Distrito, the Sangguniang Panlungsod of Bacolod

RESOLVED, to pass the following resolution:

WHEREAS, Section 9 of Article 16 of the 1987 Philippine Constitution provides that the State shall protect consumers from trade malpractices and from substandard or hazardous products;

WHEREAS, Paragraph B of Article 2 of Republic Act No. 7394 or the Consumer Act of the Philippines provides that the State shall protect the public against deceptive, unfair, and unconscionable sales acts and practices;

WHEREAS, Under City Ordinance No. 565 Series of 2011, Chapter 5, Article 19 Section 62 f provides that the City Treasurer is hereby required to keep full sets of secondary standards for the use in testing of weights and measures instruments;

WHEREAS, under Section 62 9 (I) all retail outlets shall be responsible for the proper calibration and accuracy of their dispensing pumps. All dispensing pumps, must be properly calibrated quarterly and every three (3) months, and sealed by the proper authority;

WHEREAS, as we continue to face an unabated surge in fuel prices it is but proper to regularly conduct inspection of all gasoline stations and guarantee that all operating fuel pumps are accurate and ensure that their pumps are working properly.

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, to respectfully request the City Treasurer's Office Licensing Division through Honorable City Mayor Alfredo Abelardo B. Benitez to strengthen the implementation regarding the inspection, testing, calibration, and sealing of all fuel pumps in all Gas Stations in the City of Bacolod..
