
RESOLUTION RESPECTFULLY REQUESTING THE DEPARTMENT OF PUBLIC SERVICES (DPS) TO CONDUCT CLEAN-UP AND COLLECT GARBAGE IN ALL CEMETERIES IN BACOLOD CITY GENERATED DURING ALL SOULS' DAY AND ALL SAINTS' DAY.

Upon motion of Councilor Claudio Jesus Raymundo A. Puentevella, jointly seconded by Councilors Em L. Ang, Renecito S. Novero, Jason Isidro S. Villarosa and Celia Matea R. Flor, the Sangguniang Panlungsod of Bacolod

RESOLVED, to pass the following resolution:

WHEREAS, Section 15 of Article II of the 1987 Philippine Constitution provides that the State shall protect and promote the right to health of the people and instill health consciousness among them.

WHEREAS, Section 16 of Article II of the 1987 Philippine Constitution provides that the State shall protect and advance the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature.



WHEREAS, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991 mandates the Local Government Units to exercise their power which are essential to the promotion of general welfare of the people;

WHEREAS, November 1 and 2 marked the annual observance honoring the dead where people came to cemeteries to visit their loved ones;

WHEREAS, families visiting their departed relatives stayed in various cemeteries from dawn to dusk bringing with them food and beverage and leaving behind huge piles of garbage;

WHEREAS, several days after the All Saints Day and All Souls Day, there are still volumes of garbage that have remained uncollected and which can potentially cause sanitation and health problems to residents in nearby residential areas;

WHEREAS, this Resolution invites the active participation of Bacolodnon's in practices that promote a clean, safe, healthy and sustainable environment;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, to respectfully request the Department of Public Services (DPS) to conduct clean-up and collect garbage in all cemeteries in Bacolod City generated during All Souls' Day and All Saints' Day.


