ORDINANCE NO. 1280  
Series of 1979

AN ORDINANCE AMENDING ORDINANCE NO. 2422 AND 2448,  
SERIES OF 1972.

Be it ordained by the Sangguniang Panlungsod of  
Bacolod, that:

Section 1 - The sale of all kinds of fish and meat  
is hereby allowed in the Bacolod Central Public Market  
starting at 4:00 o'clock in the morning until 8:00  
o'clock in the evening.

Section 2 - Fish shall be sold only at the designa-  
ted area known as the Fish Section Central Market located  
at the North-West alley between the Guagua Building and  
the back of the Blocks facing Gatuslao Street, where  
fish tables are constructed.

Section 3 - Meat shall be sold only at the designated  
area known as the Meat Section Central Market, located at  
the South-West alley between the Guagua Building and the  
Blocks facing Gatuslao Street where meat tables are cons-  
tructed.

Section 4 - No persons or vendors are allowed to  
display, sell or keep fish and meat in their respective  
stalls whose business is expressly specified in their  
Business Permits.

Section 5 - Any vendor or person apprehended for the  
violation of this Ordinance shall be punished by a fine of  
not less than P25.00 and nor more than P50.00 or an impri-  
sonment of not more than Fifteen (15) days or both such  
fine and imprisonment at the discretion of the court.

Section 6 - All ordinances or portions thereof contra-  
ry to the provision of this ordinance are hereby repealed.

Section 7 - This ordinance shall take effect upon  
approval.
