ORDINANCE NO. 59
Series of 1981

AN ORDINANCE AMENDING SECTION 1, ITEM 2.2 OF ORDINANCE NO. 44, APPROVING GENERAL FUND SUPPLEMENTAL BUDGET NO. 3 OF THE CITY OF BACOLOD, WHICH SPECIFICALLY PERTAINS TO REVERSIONS OF FIVE THOUSAND PESOS (P5,000.00) AND TWENTY THOUSAND TWO HUNDRED FORTY-TWO PESOS (P20,242.00), REAPPROPRIATED AS FINANCIAL AID TO THE CRIME LABORATORY OF THE METRO POLICE DISTRICT FOR THE PURCHASE OF PHOTOGRAPHIC MATERIALS, AND TO COVER DEFICIENCIES IN SALARY RATES INCLUDING GSIS PREMIUMS OF THE POSITIONS FORMERLY UNDER THE ENGINEERING "K" FUND, ORDINANCES 18 AND 39, SERIES OF 1981, RESPECTIVELY, THEREBY SUBSTITUTING THE SOURCE OF FUND THEREOF, FROM "7% AID TO HOSPITAL FUND" TO EXCESS 18% AID TO THE INP, PURSUANT TO THE CERTIFICATION OF THE CITY TREASURER DATED APRIL 28, 1981.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section 1 - Section 1, Item 2.2 of Ordinance No. 44, Series of 1981, approving General Fund Supplemental Budget No. 3 of the City of Bacolod, which specifically pertains to reversions of -

- ₱5,000.00 - as financial aid to the Crime Laboratory of the Metro Police District for the purchase of photographic materials, and
- 20,242.00 - to cover deficiencies in salary rates including GSIS premiums of the positions formerly under the Engineering "K" Fund, which had been transferred to the General Fund under the current budget

is hereby amended, thereby substituting the source of fund thereof, from "7% Aid to Hospital Fund" to Excess 18% Aid to the INP, pursuant to the certification of the City Treasurer dated April 28, 1981.

Section 2 - This ordinance shall take effect as of April 14, 1981.






