AN ORDINANCE ESTABLISHING THE "BEER HAUSEN-RC COLA FOOD PAVILLION" AS PART OF THE PUBLIC MARKET OF THE CITY OF BAKOLOD.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section 1 - The "Beer Hausen-RC Cola Food Pavillion" located at the Reclamation Area shall form part of the public market as an extension of the Bacolod Central Market.

Section 2 - There shall be twenty (20) kiosks and shall be numbered consecutively from South to North.

- a) No extensions and/or alterations whatsoever of these kiosks shall be made without prior approval of the City Mayor and the Sangguniang Panlungsod.

Section 3 - The rentals for these kiosks shall be P6.00 each per day.

Section 4 - Payment of rentals shall be made on a daily basis to be collected under the direct supervision of the City Treasurer of Bacolod. Failure to pay the daily rentals on any day shall subject the occupant to a surcharge of TWENTY PERCENT (20%) of the delinquent rentals. Any occupant who is delinquent in the payment of his rental for two (2) consecutive months shall forfeit his right to the kiosk occupied by him and shall be expelled from the said kiosk without the necessity of court action, to serve the best interest of the City Government, without prejudice to the collection of delinquent rentals through civil action.

- a) Light and water bills shall be the exclusive account of the individual kiosk holder.

Section 5 - All existing market ordinances of the City of Bacolod and laws pertinent to the operation of markets in the City of Bacolod shall be applicable in the operation of the "Beer Hausen-RC Cola Food Pavillion" insofar as they are not inconsistent with the provisions of this ordinance.

Section 6 - This ordinance shall take effect upon approval.
