AN ORDINANCE AUTHORIZING THE CITY OF BACOLOD TO ACCEPT THE OFFER OF VENDORS TO ADVANCE MONEY OR EXTEND OTHER FORMS OF ASSISTANCE FOR THE REHABILITATION AND RECONSTRUCTION OF BLOCKS, STALLS, KIOSKS, AND/OR TABLES BURNED OR DESTROYED IN THE 1983 FIRE IN THE GENERAL PUBLIC MARKET AND AT THE BURGOS MARKET OF BACOLOD CITY.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section 1 - Vendors in the Central Public Market and Burgos Market may advance the cost of the rehabilitation/reconstruction of blocks, stalls, kiosks and/or tables burned or destroyed in the 1983 fire based on the plans, specifications, and estimates of the City Engineer hereto attached, which forms an integral part of this ordinance, or may undertake the rehabilitation/reconstruction of said blocks, stalls, kiosks, or tables, in accordance with plans, specifications and estimates, and under the direct supervision and control of the City Engineer.

Section 2 - Money advanced or the cost of undertaking the rehabilitation/reconstruction as provided above shall be reimbursed to the vendor subject to availability of funds of the city government.

Section 3 - Pending the return or reimbursement of money advanced or the cost of undertaking the rehabilitation/reconstruction, rentals due on the blocks, stalls, kiosks and/or tables shall be charged against said advances or the cost of undertaking the rehabilitation/reconstruction.

Section 4 - Any vendor whose block (a), stall (l), kiosk (k) and/or table (t) was burned/destroyed by the 1983 fire in the Central Public Market and Burgos Public Market and is interested to advance money or undertake the rehabilitation/reconstruction as herein provided shall signify in writing with the office of the Market Administrator who shall immediately enclose the same to the Office of the City Engineer, furnishing copies of all communications to His Honor, the City Mayor, and the Sangguniang Panlungsod.

Section 5 - This Ordinance shall take effect upon approval.
