AN ORDINANCE FURTHER AMENDING SECTION 6 OF ORDINANCE NO. 383, SERIES OF 1965 AS AMENDED BY ORDINANCE NO. 642, SERIES OF 1977, ENTITLED "AN ORDINANCE REGULATING THE ESTABLISHMENT, MAINTENANCE, AND OPERATION OF PRIVATE MEMORIAL PARK-TYPE OF CEMETERY OR BURIAL GROUND WITHIN THE JURISDICTION OF BACOLOD CITY, AND PROVIDING PENALTIES FOR VIOLATION THEREOF."

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section 1 - Section 6 of Ordinance No. 383, Series of 1965, as amended by Ordinance No. 642, Series of 1977, entitled "An Ordinance Regulating the Establishment, Maintenance, and Operation of Private Memorial Park-Type of Cemetery or Burial Ground within the Jurisdiction of Bacolod City and Providing Penalties for Violating thereof" is hereby further amended, so that as amended, the same shall read as follows:

"Section 6. - LIMITATIONS - No application shall be approved for the establishment of a private burial ground of TWENTY-FIVE (25) METERS from any dwelling house of existing subdivision."

in accordance with the provisions of the Sanitation Code of the Philippines otherwise known as Presidential Decree No. 856, specifically Section 90 subsection b thereof which provides:

"b. A burial ground shall at least be 25 meters distant from any dwelling house and no house shall be constructed within the same distance from any burial ground."

Section 2 - This ordinance shall take effect upon its approval.
