CITY ORDINANCE NO. 16 ✓  
November 11, 1986

AN ORDINANCE PROVIDING FOR THE REROUTING OF TRAFFIC OF CERTAIN PASSENGER PUBLIC UTILITY JEEPNEYS.

Be it ordained by the Sangguniang Panlungsod of Bacolod City that:

Section 1.- In order to enhance and support business activities within the PEOPLE'S MARKET, the following major city streets leading to the reclamation area and the PEOPLE'S MARKET shall be improved and opened to vehicular and pedestrian traffic:

- a. Burgos Street;
- b. Rizal Street;
- c. Luzuriaga Street;
- d. San Sebastian Street.

Section 2. - Other access roads leading to the reclamation area and the People's Market shall be developed and opened to vehicular pedestrian traffic in the future as the need arises and as funds are available.

Section 3. - Re-routing of traffic of passenger Public Utility Jeepneys (PUJ's) plying inside the expanded perimeter of Burgos-Lacson-Osario-San Juan Streets is hereby required to proceed towards the reclamation area utilizing the streets as identified in Section 1 of this Ordinance and passing along the People's Market.

✓ Section 4. - The portion of Gonzaga Street from Lacson Street to Locsin Street shall be opened for two (2) way traffic.

Section 5. - No Public Utility Jeepneys shall be allowed to enter Bonifacio Street but will proceed to their corresponding designated waiting stations.

Section 6. - Any person found violating this Ordinance shall be fined the sum of FIFTY (P50.00 PESOS, but not exceeding ONE HUNDRED (P100.00) PESOS, or an imprisonment of FIFTEEN (15) DAYS but not exceeding THIRTY (30) DAYS for the first offense; ONE HUNDRED FIFTY (P150.00) PESOS, but not exceeding TWO HUNDRED (P200.00) PESOS, or an imprisonment for FORTY FIVE (45) DAYS, but not exceeding SIXTY (60) DAYS for each succeeding offense, or both such fine and imprisonment at the discretion of the Court.

Section 7. - All other Ordinances inconsistent with the provisions of this ordinance are hereby modified and/or repealed accordingly.

Section 8. - This Ordinance shall take effect upon approval.






