CITY ORDINANCE NO. 17
November 11, 1986

AN ORDINANCE PROVIDING FOR THE ESTABLISHMENT OF WAITING STATIONS AT THE PEOPLE'S MARKET LOCATED AT THE RECLAMATION AREA.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section 1. - There is hereby established a Waiting Station at the Public Market located at the Reclamation Area.

Section 2. - The City of Bacolod shall construct and maintain covered shades in such Waiting Stations whenever funds shall be available.

Section 3. - All Public Utility Jeepneys which have existing Waiting Stations in the downtown area may maintain the same provided that every Public Utility Jeepneys route shall maintain such unit or units as may be necessary to be parked at the Waiting Stations that may be established at the People's Market.

Section 4. - Except for a few existing PUJ Waiting Stations already established inside the perimeter of Burgos-Lacson-Rosario-San Juan Streets shall be retained subject to strict observation of provisions in existing ordinances specifically identified as follows:

a. Along Gatuslao Street

is retained.

3. BMMCO

Along Locsin-Gonzaga Street,
Along Locsin Street, (East Side)
shall be transferred to Gonzaga
Street, South Side.

d. Along Cuadra Street

1. Villamonte-Central
Market

Along Locsin-Cuadra Street,
Along Cuadra Street, South Side
is retained.

2. Banago-Central Market
Banago-Libertad

Along Gatuslao-Cuadra Street to
Locsin Street, along Cuadra Street,
North Side, is retained.

Along Gatuslao-Caudra Street to
Locsin Street, along Cuadra Street,
North Side, is retained.

e. Along Nueva Street

1. Banago-Pier Service

Along Nueva-Gatuslao
Along Nueva Street, South
Side, is retained.

Section 5. - Any person violating this ordinance shall be
fined the amount of FIFTY (P50.00) PESOS, but not to exceed ONE HUNDRED
(P100.00) PESOS, or an imprisonment of FIFTEEN (15) DAYS, but not
exceeding THIRTY(30) DAYS, or both such fine or imprisonment at
the discretion of the court.

Section 6. - This ordinance shall take effect immediately upon
approval.






