CITY ORDINANCE NO. 18
November 18, 1986

AN ORDINANCE PROVIDING FOR THE ESTABLISHMENT
OF A FOOD TERMINAL AT THE PEOPLE'S MARKET
LOCATED AT THE RECLAMATION AREA.

Be it ordained by the Sangguniang Panlungsod of Bacolod
City that:

Section 1. - A food terminal is hereby established at the
People's Market located at the Reclamation Area.

Section 2. - Henceforth all vegetables, fruits, root crops
and similar products which are intended to be distributed among vendors
to be sold by them in all the public markets of the City of Bacolod
shall be unloaded at the Food Terminal established at the People's
Market.

Section 3. - Vegetables, fruits, root crops and similar products,
which are not intended for distribution, but will be sold exclusively
by any awardee in his/her block or stall, need not be unloaded at the
Food Terminal but may be unloaded at the existing public markets where
their stalls or blocks are located.

Section 4. - All other ordinances inconsistent with any of the
provisions of this Ordinance are deemed repealed and/or revoked accord-
ingly.

Section 5. - Any person found violating this Ordinance shall be
fined the sum of FIFTY (P50.00) PESOS, but not exceeding ONE HUNDRED
(P100.00) PESOS, or an imprisonment of FIFTEEN (15) DAYS but not
exceeding THIRTY (30) DAYS for the first offense; ONE HUNDRED FIFTY
(P150.00) PESOS, but not exceeding TWO HUNDRED (P200.00) PESOS, or an
imprisonment for FORTY FIVE (45) DAYS, but not exceeding SIXTY (60)
DAYS for each succeeding offense, or both such fine and imprisonment at
the discretion of the Court.

Section 6. - This ordinance shall take effect upon approval.
